#### 3. NEW BUSINESS

#### 3.1 STANDING PHYSICIAN ORDERS

Dr. Stephen Howard at Northwest Texas Hospital, Emergency Department will be provide our standing orders. This is a set of instructions or procedures that can be used in a school setting to provide basic first aid or emergency care. Also includes orders for over the counter medications that can be administered by school staff in certain situations.

#### **SUMMER NUTRITION PROGRAM**

President Tanya Burton called upon Ms. Catrina Leeper to report on the Summer Nutrition Program. Ms. Leeper reported the District would like to submit a request for waiver for participation. The Texas Department of Agriculture mandates public school authorities in the National School Lunch Program to operate a Summer Nutrition Program to provide meals to students in need during the summer months.

Ms. Leeper explained that the students that would utilize this program live outside the 2 mile radius of the school and they do not have access to public transportation. The burden of traveling to the school for lunch is too great for the students. They would have to cross railroad tracks and Highway 287 in many cases. Because of these limitations, our district qualifies for the wiaver.

These students will be given a number to call for information on local free lunches.

The waiver was approved.
